## **I. Opening Activities**

### **a. Call to Order**

President Tannis Fox called the Governing Council to order at 6:00 p.m.

### **b. Roll call of Council members**

Members present: President Tannis Fox, Vice President Kelly Horn, Gordon Lawrie, Caleb Raymer, and Larry Mirabal. Members absent: Secretary Leslie Fagre and Marilyn Fitzgerald.

### **c. Approval of agenda**

Mr. Horn moved to approve the agenda. Mr. Mirabal seconded the motion. The motion passed unanimously.

### **d. Approval of minutes from August 20, 2014 meeting**

This item was tabled to the next meeting because the final minutes were not included in the Council's packet.

## **II. Executive Session pursuant to Section 10-15-1(H)(8) of the Open Meetings Act to discuss the purchase of real property and pursuant to Section 10-15-1(H)(3) to discuss limited personnel matters**

Mr. Mirabal moved to go into executive session pursuant to Section 10-15-1(H)(8) to discuss the purchase of real property. Mr. Horn seconded. A roll call vote was taken, and all Council members voted in favor of going into executive session. Ms. Fox asked Mr. Cliff Rees, President of ATC Foundation, to join the Executive Session for discussion. At 6:50p.m., President Fox reconvened the regular session and stated that during executive session the only matter discussed was the purchase of real property and limited personnel matters, and that no action was taken.

#### **a. Student Representative Report**

Sam Lewis, Student Council President, was unable to attend the meeting. Ms. Lumley read a letter from Sam to the Governing Council. The letter updated the Council on recent activities of the Student Council including the Fiesta Parade float and working toward sustainability at ATC.

Ms. Fox reported on the ongoing facility purchase efforts by the ATC Foundation.

#### **c. PTSC Representative report**

No PTSC representative was present. Ms. Lumley updated the Council on recent PTSC activities including pizza sales on Fridays, concession stand for the ATC Cross Country Invite, and the Fiesta Parade float.

#### **d. Teacher Representative report**

Mr. Courtney White is to fill vacancy left by Gordon Lawrie, parent representative, term ending October 2016. Ms. Fox moved to approve filling the vacancy. Mr. Raymer seconded the motion. The motion passed unanimously.

#### **d. Approval of check and warrant for August 2014**

Mr. Mirabal moved to approve the check and warrant for August 2014. Mr. Raymer seconded the motion. The motion passed unanimously.


